



## Membership Form: Individuals

Food Secure Canada/Sécurité Alimentaire Canada is a Canada-wide alliance of civil society organizations and individuals working on food issues. It provides a forum and a platform for collaboration, dialogue and cooperation in development of policies and programs that improve food security in Canada and globally. Food Secure Canada/Sécurité Alimentaire Canada is based on three commitments which we understand to be essentially connected: Zero hunger, Sustainable food systems, and Healthy and safe food.

Members of FSC-SAC agree to support the Mission and Constitution of the organization (available on the website at [www.foodsecurecanada.org](http://www.foodsecurecanada.org)). Each member has a vote in elections of the Steering Committee and in decisions regarding the direction of the organization. Between Assemblies (which are held every other year), such decisions are made through an electronic discussion and voting system. FSC-SAC promotes the work of its members, collaborates in policy development, and provides space on its website where member organizations can educate the general public on their campaigns and research interests.

FSC-SAC admits organizational, individual, and associate members.

- *Organizational members* must be non-governmental organizations wholly or partly involved in food security work or research on a not-for-profit basis. Community roundtables that are attached to government for administrative purposes may be organizational members. An organizational member identifies an individual who participates in FSC and carries the organization's vote.
- *Individual members*: People with an interest in food security can also join FSC-SAC as individual members and have voting privileges. No individual member may also vote on behalf of an organization.
- *Associate members*: Organizations or individuals that work in other fields, government units, or profit-making bodies are eligible to join FSC-SAC as associate members without voting privileges or membership on the steering committee, but with access to the members' list-serv and the right to participate fully in all discussions at meetings.
